Mark Your Calendar for 2009 Holiday Financial Planning

We want to provide the best service to all of our members during the holiday season when the financial markets generally present some challenging investment and funding circumstances. For example, the overnight fed funds rate can be very volatile during the business day prior to a major holiday. Due to this anticipated market volatility during the winter holidays, the Bank's hours will be abbreviated as noted below for Advances transactions, Wire Transfer Services and the Mortgage Partnership Finance® Program.

Holiday Closures and Abbreviated Hours

FHLB Des Moines and the bond market will be closed on Thursday, November 26, 2009, Friday, December 25, 2009 and Friday, January 1, 2010 in observance of Thanksgiving, Christmas and New Year's Day.

It is anticipated the bond market will close at 1:00 p.m. Central Time (CT) on the following dates:

Wire Transfer Services will follow normal operating hours on Wednesday, November 25 and Friday, November 27; however, we will **close at 1:00 p.m. CT** on:
