Advisory Council Report

FEDERAL HOME LOAN BANK OF DES MOINES





In 2019, the Federal Home Loan Bank of Des Moines (the Bank or FHLB Des Moines) Affordable Housing Advisory Council (Advisory Council) analyzed the affordable housing needs of the Bank's 13-state District, and considered ways in which the enhanced flexibility of the amended Affordable Housing Program (AHP) regulation could be leveraged to support those needs. To begin, Advisory Council members completed an affordable housing needs assessment, which was used to prioritize housing needs that the Advisory Council would recommend the Board of Directors adopt for the 2021 AHP scoring criteria. Throughout these discussions, the Advisory Council was mindful of its guiding principles for an AHP that is responsive to the needs of the Bank's large and diverse district. These guiding principles are:

- Equitable distribution of AHP funds, evaluated over time as the percent of total AHP subsidy awarded to a given state is reasonably
 proportionate to the state's population as a percent of the Bank District's total population
- A balance of AHP funds are awarded to projects located in urban and rural areas
- A balance of AHP funds are awarded to projects that provide or preserve rental and owner-occupied housing

I am proud to report that our objectives are being achieved.

The amount of funds available for the 2019 AHP funding round was significant at \$51.5 million. These funds were awarded to 52 members to help finance 85 projects that will provide or preserve affordable homes for more than 2,600 households. Our annual Joint Meeting of the Board of Directors and Advisory Council offered an occasion to celebrate the 2019 AHP funding round, and reflect on the important role that AHP plays in supporting our members' community partnerships and impact.

I consider many aspects of my time as the Chair of the Affordable Housing Advisory Council as memorable, but the one I am most proud of is knowing that the AHP, through FHLB Des Moines members and their community partners, provides affordable homes and strengthens communities across the Bank's District.

Here is a look into our impact:

Competitive Affordable Housing Program

Since the inception of the Affordable Housing Program in 1990, FHLB Des Moines has awarded **\$635 million** to help finance affordable housing opportunities to more than **106,000 families and individuals**. In 2019, we were able to award grants to **85 projects** for **\$51.5 million** representing **2,600 units** across all 13 states in the Bank's district plus Nebraska.

Home\$tart® and Home\$tart Plus

FHLB Des Moines has awarded \$135 million in down payment and closing cost assistance to help more than 29,900 families with the purchase of a home since 1990. In 2019 through Home\$tart®, FHLB Des Moines provided nearly \$11 million to first-time homebuyers to help finance 1,897 home purchases.

Native American Homeownership Initiative (NAHI)

The NAHI program provides equity for down payment, closing cost, counseling, and/or rehabilitation assistance to eligible Native American, Native Alaskan, or Native Hawaiian households. In 2019, FHLB Des Moines awarded \$718,478 to provide down payment assistance for 58 Native households.


Community Investment Advances

FHLB Des Moines Community Investment Advances (CIA) are a reduced-rate advance to support affordable housing and economic development projects that meet targeted needs. In 2019, we granted **381 advances** totaling **\$587.6 million**.



Through the 2019 Targeted Community Lending Plan, the Bank set a goal to increase CIA originations. In response to a coordinated campaign, in a short period of time, 44 FHLB Des Moines members originated \$105.6 million in CIAs. The additional benefits of the CIA campaign included the enhancement of the product's ease of use and greater visibility among members of the product's value.

The modernized AHP regulation allows for targeted pools of funds and a great opportunity to customize scoring criteria to meet the goals of our district in ways we haven't been able to customize in the past. While we are excited for this flexibility, we are approaching it in a measured fashion. To begin, the Advisory Council recommended that points be awarded in the AHP General Fund for affordable housing serving three types of households that were not previously targeted: veterans, unaccompanied youth, and formerly incarcerated persons. I am looking forward to future Advisory Council discussions about the impact that these new points have on meeting the diverse needs of the Bank's district in the context of the AHP guiding principles.

On a personal note, I feel very lucky to have been able to attend the Federal Housing Finance Agency's (FHFA) Leadership Conference in Washington, D.C in 2019. I believe this experience helped me to understand the environment in which we operate as a Federal Home Loan Bank. It was instrumental in understanding the regulatory framework that guides our work.

2020 is looking just as promising for our council and I am excited to see how the Advisory Council flourishes under the leadership of our new Chair, Andrea Davis.
